### **THSPA MEMBERSHIP DUES**

They must be post marked by **January 24th , 2026**. On the THSPA website, you can locate the Membership Form. Member schools will posted on this website for you to verify your dues were received by THSPA. Please don't wait until the last minute to check. Dues are \$75.00 per school. **DUES MUST BE POSTMARKED BY **JANUARY 24th , 2026**. ANY SCHOOL THAT WISHES TO LIFT IN THE REGIONAL MEET WILL PAY A **\$200.00** FINE BEFORE A LIFTER CAN COMPETE. THIS FINE MUST BE PAID BY THE MONDAY BEFORE THE LAST QUALIFIERS MEET, **FEBRUARY 15th , 2026** OR THE SCHOOL'S LIFTERS WILL NOT BE ELIGIBLE TO COMPETE AT REGIONALS OR STATE.**

### **W-9 FORMS**

If your school requires a W-9 form from THSPA, then the THSPA Website has an updated copy online. Please let your finance department know this

### **2026 RULEBOOKS**

Rulebooks can be downloaded from the THSPA website. Check the 2025 Rulebook at the beginning of the season for any rule changes.

### **INVITATIONAL MEETS**

**Dual meets are no longer allowed. Tri and Quad meets must have all judges being certified.** All meet results must be sent via-e-mail as a .psm file attachment.

PowerScore software is provided free to member schools and the Meet Director must have the latest version downloaded from the THSPA website. Meet results are due by 4:00pm the Monday following your meet. I will not accept results after this time. It is your

responsibility to tell the meet director to send them to me. If something were to occur and you cannot give the results to me, make sure to contact me before the deadline.

All meets must **NO** longer be certified through the THSPA website prior to you hosting the meet, however I need you to send me an email the week of your meet. So I will be anticipating your results by Sunday. Meet results from schools that have not paid membership dues by the deadline will be withheld or dropped from the standings.

### **REGIONAL STANDINGS & LIFTER / SCHOOL NAMES**

Results are posted on the THSPA website. Check the standings weekly. If an error occurs in a lifter's or school's name, send me an email so I can correct them. Please don't use all CAPITAL LETTERS when hosting a meet.

### **LAST CHANCE TO QUALIFY MEETS**

The last date to qualify is **Feb 28th , 2026**. All results from these Last Chance meets must be received by **12:00 midnight** on this date to be counted. This is important, because everyone is sending in results across the region. If you do not see your lifter's results, please contact the meet host first. Meets not submitted on time will not be uploaded on the site.

### **WEIGHT CLASS DECLARATIONS**

The deadline for declaring a lifter who has qualified for the regional meet in more than one weight class or who is scratched is **Monday, March 2nd , 2026 at 4:00pm**. **YOU ARE RESPONSIBLE FOR THE ENTRY FEE AFTER THIS DATE IF A LIFTER IS SCRATCHED.**

### **WEIGHT CUTTING OR GAINING WARNING**

THSPA does not condone athletes cutting or gaining weight. Excessive weight loss or weight gain to a lifter can result in harm to the athlete's health. THSPA wants the health of your lifters to be held in upmost regard. There is no rule against this type of training just a warning that THSPA or any Regional Directors will not be held liable for lifters who chose to cut or gain excessive weight.
